## INSTRUCTIONS FOR THE PROSPECTIVE MOOSIES

- 1. Before committing the *Wasiyyat* (*Will*) to writing, please read or have read out to you the Promised Messiah<sup>as</sup>'s booklet *Al-Wasiyyat* and the Appendix thereto and Minutes of the First Meeting of the Board of Directors *Sad'r Anjuman Ahmadiyya* Qadian held on January 29, 1906 duly verified by the Promised Messiah<sup>as</sup>. The foremost condition of *Wasiyyat is* that the prospective *Moosi* must be righteous, obedient to the laws *of Shariah*, one who gives precedence to the faith over worldly affairs, and must be a clean, pure and pious Ahmadi.
- 2. The Wasiyyat is to be executed in good health. A 'death-bed' Wasiyyat shall not be accepted.
- 3. A *Wasiyyat* which includes immovable property should, as far as possible, be attested by the heirs/partners of the prospective *Moosi*.
- 4. The *Wasiyyat* made by a married woman must be witnessed by her husband if he is alive. The *Haq Mahr\** is also part of a woman's property to be included in *Wasiyyat*. It should also be specified whether *Haq Mahr* has been received or is still due from the husband. The details of jewelry (type, weight and estimated current value) should also be given. Monthly income of husband should also be mentioned and, if he is *a Moosi*, his *Wasiyyat* number should be given.
- 5. If some immovable property is included in a *Wasiyyat*, such property should better be officially registered in the name of the *Moosi. Moosies* who find it difficult to execute *Wasiyyat* due to legal restriction(s) can transfer as gift, their property to *Sad'r Anjuman Ahmadiyya* Pakistan Rabwah during their life time. And they should send a copy of legal documents of the gifted property to *Sadr Anjuman Ahmadiyya*. And if there is any complication in gifting the property, then all the property present at the time of *Wasiyyat* and its location, etc. should be written in the *Wasiyyat* form including its current market value. The value should be evaluated under the supervision of the local *Anjuman*, and a separate certification should be included from the local President verifying that the value of the property mentioned is true. Moreover, it should also be verified that the prospective *Moosi* does not have any other property.
- 6. It will be required of every *Moosi* to pay *Chanda Hissa Amad* at the rate of *Chanda Aam* on the income of his/her property. He/She should also pledge to pay *Hissa Amad* on monthly income in addition to the above, and should do so every month. Moreover, it will be the duty of every *Moosi* to declare his/her annual income according to Schedule 'C' to the office *of Bahishti Maqbarah*. (In case of a person residing outside of Pakistan the *Wasiyyat* form should be forwarded to *Wakilul Mal II*, *Tahrik-e-Jadid Anjuman Ahmadiyya*, Pakistan, Rabwah).
- 7. The payment of *Hissa Amad will* be due from the date that the applicant applied for, *i.e.*, date of writing of *Wasiyyat* /date *of* acceptance, even though the Certificate may be given later.
- 8. Any *Moosi* who does not pay *Chanda Wasiyyat* after it is due for six months or stops paying after once starting it and does not inform the Office of *Majlis Karpardaz Masalih Qabristan* Rabwah of reasons, and does not seek permission for a relaxation, his/her *Wasiyyat will* be brought forth for cancellation.
- 9. Sad'r Anjuman Ahmadiyya will have the right not to accept a Wasiyyat or cancel a Wasiyyat after it has been approved without giving reasons, and the decision of Sad'r Anjuman Ahmadiyya will be final.
